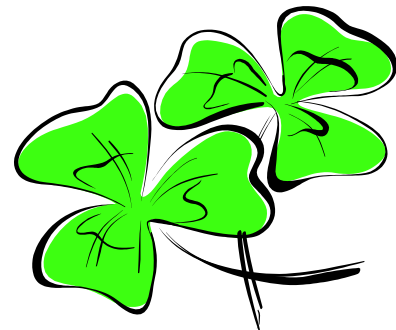

Committee Reports
